### INVITATION TO BID

## PROCUREMENT OF REHABILITATION OF FIRE ALARM AND DETECTION SYSTEM AND RAMP CONSTRUCTION OF VALENZUELA MEDICAL CENTER Public Bidding VMC No. 2020-019

The *Valenzuela Medical Center*, through the INCOME/GAA intends to apply the sum of *Four Million Nine Hundred Sixty-Five Thousand Eight Hundred Sixty-Three Pesos and 30/100 Only (P 4,965,863.30)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Rehabilitation of Fire Alarm and Detection System and Ramp Construction of Valenzuela Medical Center*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The *Valenzuela Medical Center* now invites sealed Bids for eligible Bidders for the *Procurement of Rehabilitation of Fire Alarm and Detection System and Ramp Construction*. Completion of the Works is required *one hundred eighty (180) days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act",.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines

3. Interested bidders may obtain further information from *Valenzuela Medical Center* and inspect the Bidding Documents at the address given below from *February 27, 2020 to March 18, 2020 10:00 am at the VMC BAC Office*.
4. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (P5,000.00)**.


*The method of payment will be in cash, manager's check, bank guarantee and surety bond. The Bidding Documents shall be received personally by the prospective bidder or his authorized representative. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.*

5. The Valenzuela Medical Center will hold a Pre-Bid Conference open to all interested parties on **March 6, 2020, 10:00am** at VMC BAC Office, 2<sup>nd</sup> Floor, Annex 2, Padrigal St., Karuhatan, Valenzuela City which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before **March 18, 2020** at 10:00 am at *Valenzuela Medical Center, BAC Office*. All bids must be accompanied by a bid security in the form of cash, Manager's check or Cashier's check of two (2%) percent, one point five percent (2%) if Bank Draft or Bank Guarantee, 5% surety Bond and Bid Securing Declaration (notarized), of the total amount of bid.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The *Valenzuela Medical Center* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
