**INVITATION TO BID**  
**PROCUREMENT OF VARIOUS COVID-19 MEDICAL EQUIPMENT CY 2020**  
**PUBLIC BIDDING NO. VMC-2020-028**

1. The Valenzuela Medical Center (VMC), through the General Appropriations Act CY 2020, intends to apply the sum of **Philippine Currency: FOURTEEN MILLION FOUR HUNDRED EIGHTY FIVE THOUSAND PESOS ONLY (Php14,485,000.00)** being the Approved Budget for the Contract (ABC) to payments for the **Procurement of Various COVID-19 Medical Equipment CY 2020** under PB No. **VMC-2020-028**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The VMC now invites sealed Bids from eligible Bidders for the procurement of the above-captioned package. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, entitled "Instructions to Bidders".
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" and is restricted to Filipino citizens/sole proprietorships, partnerships, or corporations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act No. 5183 and subject to Commonwealth Act 138.
4. Only Bids from Bidders who passed the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents entitled, "ITB". The Bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine the responsiveness of the bid submission to the technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.
5. Interested bidders may obtain further information from the VMC and inspect the Bidding Documents at the address given below from 9:00am-11:00am and 2:00pm-4:00pm starting June 08, 2020.
6. The VMC will hold a Pre-Bid Conference for this bidding activity on **June 16, 2020, 1:00 pm** at the Valenzuela Medical Center, Padrigal St., Karuhatan, Valenzuela City which shall be open to prospective bidders.

A complete set of Bidding Documents may be acquired by interested Bidders from June 5, 2020 to June 23, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB as follows:

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and an electronic copy from BAC Secretariat's Office provided that the bidders shall pay the applicable fee for the bidding documents not later than the submission of their bids

7. Bids must be duly received by the BAC Secretariat at the address below on or before June 30, 2020 @1:00pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.
8. Bids and eligibility requirements must be delivered to the address below on or before June 30, 2020 **1:00pm**, at the VMC BAC Secretariats' Office.
9. Bid Opening and Eligibility Check will be on **June 30, 1:00pm**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late submission of bids will not be entertained. All bids must be accompanied by a Bid Security in the prescribed form, amount and validity period.
10. The Valenzuela Medical Center reserves the right to accept or reject any bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
