**INVITATION TO BID**

**PROCUREMENT OF VARIOUS COMMONLY-USED MEDICAL SUPPLIES – 5 ITEMS  
 PUBLIC BIDDING NO. VMC – 2021 – 018**

1. The Valenzuela Medical Center (VMC), through the General Appropriations Act/Income CY 2021, intends to apply the sum of **Ten Million Seven Hundred Fourteen Thousand Eight Hundred Pesos and 90/100 Pesos Only (PhP 10,714,800.90)** being the Approved Budget for the Contract (ABC) to payments for the **Procurement of Various Commonly-Used Medical Supplies – 5 Items** under **PB No. VMC-2021 - 018**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Valenzuela Medical Center (VMC) now invites bids for the above Procurement Project. Delivery of the Goods is *required within the period specified under Section VI. Schedule of Requirements*. Bidders should have *completed, within Two (2) years from the date of submission and receipt of bids*, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information starting April 24, 2021 and inspect the Bidding Documents at the address given below during 9:00am-11:00am and 2:00pm-4:00pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on April 24, 2021, 11:00am from the given address and upon payment of a non-refundable fee in the amount as follows:

<b>ABC to be Bid</b>	<b>Maximum Cost of Bidding Documents (in Philippine Peso)</b>

More than 500,000 up to 1 Million	1,000.00
More than 1 Million up to 5 Million	5,000.00

The Procuring Entity shall allow the bidder to present its proof of payment for the fees either *in person, by facsimile, or through electronic means.*]

[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]
