



**INVITATION TO BID**

**DESIGN AND BUILD OF FOUR (4) STOREY BUILDING  
WITH ADMINISTRATIVE OFFICES FOR CY 2022  
PUBLIC BIDDING NO. VMC 2022-005**

The *Valenzuela Medical Center*, through the GAA/INCOME intends to apply the sum of *One Hundred Thirty Million Pesos Only (P130,000,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Design and Build of Four (4) Storey Building with Administrative Offices for CY 2022*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The **Valenzuela Medical Center** now invites bids for the above Procurement Project. Completion of the Works is required Three Hundred Sixty Five (365) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
3. Interested bidders may obtain further information from **Valenzuela Medical Center** and inspect the Bidding Documents at the address given below from November 26, 2021 to December 15, 2021, 10:00 am.
4. A complete set of Bidding Documents may be acquired by interested bidders on November 26, 2021 from given address *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand Pesos Only (P50,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person, by facsimile or through electronic means.
5. The **Valenzuela Medical Center** will hold a Pre-Bid Conference<sup>1</sup> on December 03, 2021, 10:00 am at VMC BAC Office, 2<sup>nd</sup> Floor, Annex 2, Padrigal St., Karuhatan, Valenzuela City and/or through videoconferencing/webcasting *via ZOOM or Google Meet*, which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through manual submission or online or electronic submission on or before December 15, 2021 at 2pm at Valenzuela Medical Center, BAC office. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
8. Bid opening shall be on December 15, 2021 at 2pm at Valenzuela Medical Center, BAC office and/or through video conferencing/webcasting *via ZOOM or Google Meet*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
9. The **Valenzuela Medical Center** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
